Description and purpose of the product

VentiAir air handling units of the TYPE range are intended for transport and treatment of air in low and high pressure ventilations, heating and air conditioning systems without the risk of explosion, where the effects of weather are not directly present, **not** intended for forced heat and combustion product removal. VentiAir units of TYPE range with heat recuperation are used to recover heat from the exhaust air to preheat the fresh supply air for ventilation of living and small civic spaces without risk of explosion and of environments without organic solvents and explosive gases. The intake air must be free of dirt, oil aerosols and corrosive or abrasive substances.
